

Advanced's cloud-based Gift Aid portal hits £1 billion milestone

Advanced's innovative Gift Aid portal has now helped leading British charities process over £1 billion in value of gross donations since its introduction in 2013, resulting in tax repayments of circa one quarter of a billion pounds. The cloud-based solution helps charities successfully manage the online Gift Aid processing requirement for HMRC Charities Online, saving both time and eradicating errors. Some of the largest charities using the portal include Save the Children UK, RSPB, RSPCA, WWF, Plan UK, The English Heritage Trust, Marie Curie, Guide Dogs for the Blind Association, Cats Protection and Amnesty International UK.

Advanced developed the Gift Aid portal for its not-for-profit clients, which integrates with its fundraising solutions for charities. Feedback from some of the leading charities using the portal have indicated benefits in four key areas:

- guarantees that report submissions have been validated and have been successfully processed
- alerts if there are errors in the entry, prior to submission, which speeds up the process by not having to re-submit data unnecessarily
- online automation removing the previous manual administrative process of printing, signing, and posting each form
- faster processing which means charities get receipt of the valuable Gift Aid funds more quickly

"Advanced provides us with a very reliable and effective solution to process Gift Aid claims electronically in line with the HMRC requirement," says Tony Gamble, Head of IT for Cats Protection. "We are now able to process claims 50% faster compared to paper claims which used to take the team a whole afternoon! We claim Gift Aid income on behalf of our 250 volunteer-run branches who care for unwanted cats, so we very much welcome the increased efficiencies."

Gift Aid is worth £1.3 billion a year

It was introduced in 2000 by the UK Government as a way for charities or Community Amateur Sports Clubs (CASCs) to increase the value of monetary gifts from UK taxpayers by claiming back the basic rate tax paid by the donor on the donation. It increases the value of donations by a quarter at no extra cost to the donor.

All Gift Aid claims must now be made online directly to HMRC and organisations processing claims in excess of 1,000 records must be uploaded directly to the Government Gateway.
