"We see this acquisition as a win-win for both Peppercon's and Raritan's customers, who will have access not only to the products that they are currently buying, but also to a range of complementary offers, supported by the same channel and people that they have grown to trust and with whom they have developed excellent relationships."

This acquisition bolsters Raritan's leadership position in remote management both inside and outside the data center. In addition, Raritan's enterprise customers will benefit from the additional functionality that will be incorporated into Raritan's existing IT infrastructure management products, as well as from the increased technical and support resources in Europe.

"Our merger with Raritan opens new horizons for Peppercon's offerings," said Christian Pätz, CEO of Peppercon. "We now have the opportunity to increase sales of our leading embedded remote management technology through the worldwide presence of Raritan Computer, especially outside of Europe.
