Government Must Prioritise Visa Reform to Prevent Doctor Staffing Crisis

Following BBC reports (http://www.bbc.co.uk/news/health-43898969) that immigration rules continue to hamper Trusts' ability to recruit overseas doctors, prompt government action from the new Home Secretary is vital to avoid further shortagesat a time when the UK is facing a dearth of home-grown doctors.
